How has your school's spending improved PE attainment?	A higher number of children working at greater depth level across PE. We focus on Gymnastics and children's core strength as this helps them in all aspects of PE. Cycling proficiency - 98% of children are now able to confidently ride a bike proficiently. Swimming - 98% of children have left school being able to swim and increased their water safety knowledge.

How has your school's spending increased pupil PE and sport activity levels?	The percentage of children participating in extra-curricular activities has increased in comparison to 2022-23. We collect this data for Pupil Premium, EAL, SEND and girls and through pupil voice, we offer a wide range of extra-curricular activities.
How has your school's spending increased school sport participation?	We have entered every school school sport competition possible; with the maximum number of teams permitted so we can offer all pupils the opportunity to participate in sport. We also facilitate participation in activities such as Park run.
How has your school's spending increased pupil participation in extra-curricular activities?	Through pupil voice, we now offer a wider range of extra-curricular activities that hits our target groups. The clubs are full/ over-subscribed.
How has your school's spending increased staff training and continued professional development (CPD)?	Staff team teach with specialist teaching staff for half a term; then teach independently for the remainder of the half term. Staff are more confident in teaching gymnastics and dance specifically this year through this model.

How has your school's spending increased staff participation in extra-curricular activities and school sports competitions?	All teachers lead an extra-curricular activity. Some Teaching Assistants also volunteer with these activities. A dozen staff members volunteer or take part in Park runs with children at the weekends.
How has your school's spending improved swimming attainment?	98% of pupils left school being able to swim and be water safety confident. Our more able children received extra swimming sessions and we won the swimming gala.
How has your school's spending improved water safety awareness?	98% of pupils left school with water safety confidence; and only 8 children are entering Y6 unable to swim out of a cohort of 50.

The swimming & cycling models have been sustainable because pupils in lower KS2 have access to regular swimming lessons which has meant that by Y6, most are already able to swim. In the end, this means we can reduce the extra swimming slots down to a more sustainable level. Teachers are more confident in complex areas of PE (i.e. gymnastics) with the support of the specialist. Extra curricular activities are up-and-running. We will continue to offer a wide range to pupils using pupil voice and
